ORDINANCE NO. 26-1113-M

CAPITAL ORDINANCE OF THE BOROUGH OF SADDLE RIVER, IN THE COUNTY OF BERGEN, NEW JERSEY AUTHORIZING THE MAKING OF VARIOUS PUBLIC IMPROVEMENTS AND ACQUISITIONS IN, BY AND FOR THE BOROUGH, APPROPRIATING THEREFOR THE SUM OF \$284,000 AND PROVIDING THAT SUCH SUM SO APPROPRIATED SHALL BE RAISED FROM A COUNTY GRANT AND FROM THE CAPITAL IMPROVEMENT FUND OF THE BOROUGH.

BE IT ORDAINED by the Borough Council of the Borough of Saddle River, in the County of Bergen, New Jersey, as follows:

Section 1. The Borough of Saddle River, in the County of Bergen, New Jersey (the "Borough") is hereby authorized to make the following public improvements and acquisitions in, by and for the Borough, including all work, materials and appurtenances necessary and suitable therefor:

(A) Rindlaub Park

Undertaking of the Rindlaub Park Path Improvements Project (Phase IV).

Estimated Cost: \$180,000

(B) Police Department

Installation of security cameras at emergency services and Department of Public Works buildings.

Estimated Cost: \$50,000

(C) Fire Department

Acquisition of the following: (i) turnout gear; (ii) personal protective equipment; and (iii) portable radios.

Estimated Cost: \$54,000

Section 2. The sum of \$284,000 is hereby appropriated to the payment of the cost of the improvements and acquisitions authorized and described in Section 1 hereof (hereinafter referred to as "purpose"). Said appropriation shall be raised from a County grant and from the Capital Improvement Fund of the Borough. The sum of \$90,000 received or to be received as a grant from the County of Bergen Open Space, Floodplain Protection, Recreation, Farmland and Historic Preservation Trust Fund is hereby appropriated to the payment of the cost of the improvement to Rindlaub Park authorized in Section (1)(A) above. The sum of \$194,000 is hereby appropriated from the Capital Improvement Fund of the Borough to the payment of the cost of the purpose.

Section 3. Said improvements and acquisitions are lawful capital improvements of the Borough having a period of usefulness of at least five (5) years. Said improvements and acquisitions shall be made as general improvements, no part of the cost of which shall be assessed against property specially benefited.

Section 4. The capital budget is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Borough Clerk and is available for public inspection.

Section 5. This ordinance shall take effect at the time and in the manner provided by law.
